We are an independent and voluntary organisation which provides nursing care for those suffering from a life limiting illness who prefer to die in their own homes and to give support and help to those caring for them.

The service is entirely free to the patients and their families.

#### Note

Trustees must be able and willing to give time to the efficient administration of the Charity and the fulfilment of its trusts. In general this would involve attending at least 12 meetings per year and being able to read papers and respond to e-mail. They will be selected on the basis of relevant experience and skills, and in the knowledge that they will take an active part in the running of the Charity.

Before becoming a Trustee, a person should consider whether, by accepting that position, he or she will be placed in a position of substantial or continuing conflict of interest. A Trustee is bound to withdraw from discussion of matters in which he or she will be subject to such a conflict.

A proper process of induction will be provided for the new Trustee. That will include a copy of the Hospice UK 20 Minute Guide to Being a Hospice Trustee.

#### Selflessness

Trustees of Hospice at Home have a general duty to act in the best interest of Hospice at Home as a whole. They should not do so in order to gain financial or other material benefits for themselves, their family, their friends or the organisation they come from or represent.

#### Integrity

Hospice at Home's Trustees:

- should not place themselves under any financial or other obligation to outside individuals or organisations that might seek to influence them in the performance of their role;
- as well as avoiding actual impropriety, should avoid any appearance of improper behaviour;
- should avoid accepting gifts and hospitality that might reasonably be thought to influence their judgement.

Objectivity Amended 14/02/23 In carrying out their role, including making appointments (including trustee appointments), awarding contracts, recommending individuals for rewards and benefits or transacting other business, Hospice at Home's trustees should ensure that decisions are made solely on merit.

#### Accountability

Hospice at Home's trustees:

- have a duty to comply with the law on all occasions in accordance with the trust placed in them and in such a way as to preserve public confidence in Hospice at Home;
- are accountable for their decisions and actions to the public, funders and service users. They must submit themselves to what scrutiny is appropriate to their role.

#### Openness

Hospice at Home's trustees:

- should ensure that confidential material, including material about individuals, is handled in accordance with due care;
- should be as open as possible about their decisions and action that they take. They should give reasons for their decisions and restrict information only when the wider interest clearly demands.

#### Honesty

Hospice at Home's trustees:

- have a duty to declare any interests relating to their trustee role and to take steps to resolve any conflicts that may arise. Where private interests of a trustee conflicts with their trustee duties, he/she must resolve this conflict in favour of the trustee role;
- must make relevant declarations of interest in the different circumstances and roles they play, both within and outside Hospice at Home.

#### Leadership

Hospice at Home's trustees:

- should promote and support the principles of leadership by example;
- must respect the role of the Chief Executive. There will be circumstances under which trustees will be working directly with Hospice at Home staff. Guidelines for such working relationships must be clear to both staff and trustees and, when these occasions arise, the Chief Executive/Chair should be informed in advance.

#### I declare that:



I am over age 18.

I am not an undischarged bankrupt.

I have not previously been removed or disqualified, on the grounds of misconduct or mismanagement in the administration of a charity, from trusteeship of a charity by a Court or the Charity Commission.

I am not under a disqualification order under the Company Directors' Disqualification Act 1986.

I have not been convicted of an offence involving deception or dishonesty (unless the conviction is spent).

# **CONFLICTS OF INTEREST**

- Any trustee who has a financial interest in a matter under discussion should declare the nature of his /her interest and withdraw from the room, unless he/she has a dispensation to speak.
- If a trustee has any interest in the matter under discussion which creates a real danger of bias, that is the interest affects him/her or a member of his /her household more than the generality affected by the decision, he/she should declare the nature of the interest and withdraw from the room, unless he/she has a dispensation to speak.
- If a trustee has any other interest which does not create a real danger of bias, but which might reasonably cause others to think it could influence their decision, he/she should declare the nature of the interest, but may remain in the room, participate in the discussion and vote if he/she wishes.
- If in any doubt about the application of these rules he/she should consult with the Chairman.
